Attorney General Bondi:

We write to express our significant concern about recent reports regarding BrainCo, a neural-technology company purportedly funded by the People's Republic of China (PRC), and allegations of its harvesting of personal information of United States citizens. We urge the Administration to investigate BrainCo for risks to American national and economic security and to protect Americans' personal information from potential access by a foreign adversary.

Based in Hangzhou, BrainCo is one of the PRC's "six little dragons," or leading technology companies supporting the Chinese Communist Party's (CCP) ambitions to dominate new and emerging technologies.² In the U.S., BrainCo offers "FocusCalm," a headset that collects electroencephalogram (EEG) information, data on brain activity, from users purportedly to help with meditation, athletic performance, and sleep. FocusCalm headsets are used by numerous leading American professional sports teams, Olympic organizations, and universities.³ The company also provides connected prosthetics including a bionic hand powered by

Earlier this year, the Department of Justice implemented its Data Security Program to protect Americans' sensitive personal information from foreign adversaries, including the PRC.8 The Department of Commerce's Information and Communications Technology and Services Program has likewise taken action to address unacceptable risks to national security stemming from transactions involving connected vehicles and foreign adversaries. 9 Moreover, the Federal Trade Commission's new and longstanding authorities enable it to hold CCP-aligned companies accountable when their unfair or deceptive data practices harm American consumers. 10
